4 A RESOLUTION relating to Sound Transit, providing recommendations to the Sound Transit  
5 Board as to the content of the proposed Sound Transit 3 (ST3) ballot measure to be  
6 submitted to the voters in November 2016.

7  
8 WHEREAS, a Regional Transit Authority (Sound Transit) was created for the Pierce, King, and  
9 Snohomish County region by action of their respective county councils pursuant to RCW  
10 81.112.030; and

11 WHEREAS, in November 1996, the voters of the three-county Sound Transit district approved  
12 *Sound Move*, a ten-year regional transit system plan for high-capacity transit in the  
13 Central Puget Sound Region; and

14 WHEREAS, in November 2008, the voters of the three-county Sound Transit district approved  
15 *Sound Transit 2*, a 15-year regional transit system plan for high-capacity transit in the  
16 Central Puget Sound Region; and

17 WHEREAS, on December 18, 2014, through Resolution R2014-31, the Sound Transit Board  
18 adopted an updated and modified Regional Transit Long-Range Plan, setting out goals,  
19 policies, and strategies to guide the long-term development of the region's high-capacity  
20 transportation system; and

21 WHEREAS, Sound Transit Resolution R2014-31 also directed Sound Transit staff to develop  
22 priorities for the next set of investments to be added to the regional high-capacity  
23 transportation system, with a goal to develop the "Sound Transit 3" (ST3) plan to be  
24 submitted to the voters; and

1 WHEREAS, Sound Transit has engaged in a multi-year planning process with the public, other  
2 agencies, and communities to identify and evaluate potential projects for inclusion in the  
3 ST3 proposal, and to evaluate several revenue and investment scenarios; and

4 WHEREAS, Sound Transit intends to place an ST3 proposal before the voters of the region in  
5 November 2016; and

6 WHEREAS, a continued regional investment in high-capacity transit, including light rail (Link),  
7 commuter rail (Sounder), and express bus service and facilities (ST Express), will  
8 provide fast, frequent, reliable connections among the region's major population and  
9 employment centers; NOW, THEREFORE,

10 **BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SEATTLE, THE**  
11 **MAYOR CONCURRING, THAT:**

12 Section 1. The City Council and Mayor of Seattle commend Sound Transit for its  
13 deliberative and inclusive planning process for Sound Transit 3 (ST3); and recognize the need  
14 for new transit investments throughout the Sound Transit region. The City Council and the  
15 Mayor encourage Sound Transit to accelerate the project delivery schedule and provide ST3  
16 transit service to voters as quickly as possible. The City Council and Mayor support including  
17 the following components in the ST3 package to be submitted to voters.

- 18 a. The ST3 package should construct an infill light rail station at South Graham  
19 Street.
- 20 b. The ST3 package should construct an infill light rail station at Northeast 130th  
21 Street.
- 22 c. The ST3 package should construct a light rail extension from Downtown Seattle  
23 to Ballard that includes a new tunnel through Downtown Seattle to support

1 regional operation of the light rail system, provides a grade-separated alignment  
2 to Ballard, and considers a potential Interbay alignment to the west of 15<sup>th</sup>  
3 Avenue West. The ST3 package should allow for future consideration and  
4 evaluation of a potential Ship Canal tunnel crossing, if cost savings within the  
5 ST3 program or additional funding resources become available.

6 d. The ST3 package should construct a light rail extension from Downtown Seattle  
7 to the West Seattle Junction that includes a grade-separated alignment through  
8 West Seattle. The ST3 package should allow for future consideration and  
9 evaluation of a potential tunnel alignment through West Seattle, if cost savings  
10 within the ST3 program or additional funding resources become available.

11 e. The ST3 package should include funding for a robust equitable Transit-Oriented  
12 Development program to capitalize on ST3 project opportunities.

13 f. The ST3 package should include funding for a robust bicycle and pedestrian  
14 access program to maximize ridership and interconnectivity of ST3 projects.

15 g. The ST3 package should include Madison Street Bus Rapid Transit and  
16 enhancements to the RapidRide C and D bus lines as early deliverables to address  
17 current and anticipated transit demand in these corridors.

18 h. The ST3 package should include funding for planning to extend light rail from the  
19 West Seattle Junction to Burien and from Ballard to the University District. The  
20 results of these planning studies will enable Sound Transit to update the Long-  
21 Range Plan for future investments.

22 Section 2. The City Council and Mayor acknowledge that the Puget Sound region  
23 continues to experience rapid growth and that the region's transit needs are great. We also

1 acknowledge that Sound Transit has been granted limited options for funding these needs, which  
2 will only become more expensive over time. Given these realities, the Council and Mayor  
3 endorse Sound Transit's proposed mix of revenue options while also committing to support the  
4 agency in seeking federal grants and other partnerships to fully leverage the investment of local  
5 tax dollars. The City Council and Mayor appreciate Sound Transit's work to review and revise  
6 the Financial Policies in a way that responsibly and equitably finances the full suite of ST3  
7 projects while ensuring our regional transit assets will be maintained in a state of good repair.  
8 The City Council and Mayor recommend that the ST3 plan continue past practices of allowing  
9 for contributions from state and local governments, as well as the private sector, to extend or  
10 enhance elements of the System Plan approved by voters.

11       Section 3. The City of Seattle has a strong history of partnering with Sound Transit to  
12 help deliver Sound Move and Sound Transit 2 projects. In order to accelerate the delivery of  
13 transit improvements in Seattle, the City is committed to actively collaborating with Sound  
14 Transit early in the environmental assessment and design phases of ST3 projects to refine and  
15 provide certainty around project scope and cost estimates, and to streamline and expedite the  
16 permitting process.

17       The City pledges to develop an agreement with Sound Transit for delivering ST3 projects  
18 that could include establishing an inter-agency team made up of Sound Transit project managers  
19 and City department directors or managers; a Mayor-appointed coordinator to manage the City's  
20 efforts across departments while also serving as a single point of contact for Sound Transit  
21 project staff; and tools, processes and potential code amendments necessary to streamline  
22 permitting and facilitate other regulatory procedures.

1           Such an agreement will necessarily depend on Sound Transit providing a commensurate  
2 level of executive commitment, financial planning and staff resources to effectuate our mutual  
3 desire for accelerated project development. The City hopes such an agreement will be in place to  
4 immediately begin work, if voters approve the ST3 measure in November.

5           Section 4. The City of Seattle applauds the work of Sound Transit in its project labor  
6 agreements to ensure we have high apprenticeship utilization rates, strong participation by  
7 disadvantaged business enterprises and women- and minority-owned businesses, and high usage  
8 of well-trained, local unionized labor. We encourage the Sound Transit Board and staff to look at  
9 adoption of priority hire practices to ensure that the workers in the region who live in  
10 economically distressed areas are benefiting from large construction projects that will come  
11 along with ST3 adoption.
